The applicant and the owner take full responsibility for any errors, omissions or mistakes contained either in this application or any submissions made in connection herewith and agree that the issuance of the Building Permit hereby applied for shall not relieve the applicant, the owner or any other person from complying strictly with the Ontario Building Code Act, the Ontario Building Code, all By-laws of the Municipality of Middlesex Centre and all other applicable laws.
